Changes to Bylaws and Standing Rules Recommended

Did you know that we have only one opportunity per year to change the Bylaws and Standing Rules of the Friends? And your vote at the Annual Meeting on Jan. 27, 2013, is necessary to do it! You can read the entire Bylaws and Standing Rules at <u>www.friendsofsapl.com</u>. The Board of FOSAPL has recommended the following revisions to the Bylaws (shown in italics) for consideration by the membership:

- Section 1. The name of this corporation shall be ... *also known as FOSAPL*.
- Section 2. ...the San Antonio Public Library (also known as SAPL).
- New Section 4. This corporation operates under the Memorandum of Understanding that was approved by the FOSAPL Board on January 16, 2011, and by the SAPL Board of Trustees on January 26, 2011, concerning operation of the BookCellar; and under the Memorandum of Understanding

Remember, that for each membership one Friends branch may receive \$5 added to their account but only if you so specify that branch from year to year (an additional \$5 must be submitted for more than the first branch). **Life members**—we still need for you to send in your membership envelope with current contact information and any branch designation you may desire!

The Friends of the San Antonio Public Library met on Sunday, November 18, at 2:00 p.m. at the John Igo Branch Library. Those present were: Nancy Gandara, Linda Arronge, Judy Wilson, Anne Long, Pat Bjornson, Evelyn Bonavita, Arline Braswell, Antoinette Franklin, Jackie Fremming, Bruce Gill, Yolanda Kirkpatrick, Claudia Kohler, Karen Matson, Mary McAfee, Bob Mason, Pat Mendiola, Patricia Peak, Larry Purkey, Ronnie Retzloff, and Jill Zimmerman.

The Minutes of the September 16, 2012, meeting were printed in the November/ December 2012 *SAPLings*. **Jackie Fremming** moved and **Robert Mason** seconded the motion that the Minutes be accepted as they appeared in the Newsletter. The motion passed.

President's Report—Nancy Gandara reviewed some of the many meetings she attended and announced that Ramiro Salazar will be the keynote speaker at our Annual Meeting in January.

Treasurer's Report—Judy Wilson called for questions on the August 31, 2012, Treasurer's Report, which had not been available at our last meeting. There were no questions. Mary McAfee made a motion we accept the report for audit. Bruce Gill seconded the motion and the motion passed. We moved on to the October 31, 2012, Treasurer's report. Judy reported that the net assets for FOSAPL use total \$56,216.31. She also mentioned that we paid \$50,000 to SAPL for library support in 2012. There being no questions or further discussion, Mary McAfee made the motion we accept the October 31, 2012, Treasurer's report for audit. Bruce Gill

seconded the motion, and the motion passed. Nancy Gandara highlighted the fact that Branch groups' purchases for and support of branch libraries

amounted to \$58,729.35, YTD. Library Board Report— Jean Brady announced three new members of the Board of Trustees: Grace Sanchez from **District 3, Andrea Sanchez** from District 4. and Linda Nairn from District 10. She reported that the Library Foundation members are taking bus trips to the branches and have brought back to the Foundation meeting how much support is given to libraries with Friends groups, as opposed to libraries without a Friends group.

Library Administration— Ruben Flores, Interim Asst. Director of Support Services, introduced Dale McNeill, the new Assistant Director of Public Services, who outlined some of the projects that will be going forward now that the budget had passed. A new addition to the library system will be Express Collections. These collections of 1,000 to 1,100 current bestsellers or perennially popular books will be available on the shelves but not be part of the books that can be requested. This gives library patrons a better chance to walk into the library and find a popular book on hand without waiting for a request.

Architects have been selected for the new libraries in District 9 and District 2. Facilities improvements will soon begin on four branches (Forest Hills, Brook Hollow, Thousand Oaks and Johnston). **Ruben Flores** introduced the purchase process procedure for branch managers and Friends groups, which is intended to improve the timely acquisition of items and services that branch Friends' groups have approved for their respective branches.

Library Foundation—Carol **Black** was pleased to announce that the Authors and Illustrators event was a huge success, raising \$50,000 through sponsorship. Jill Giles will be the new Chairman of the Board, and there are 18 new board members. The Foundation, in conjunction with the Southwest School of Art, is preparing for the 2013 Texas Book Festival of San Antonio in April of 2013. Carol invited FOSAPL to participate with a booth and encouraged Friends to volunteer.

BookCellar—**Linda Arronge** reported that the BookCellar sales are at \$68,000 as of the end of October 2012, and the donation box is doing very well.

Membership—In the absence of Christie Smith, Nancy Gandara reported that we now have 345 new members, and she reminded everyone that the 2013 membership renewal drive had started.

Nominating committee— Mary McAfee and Arline Braswell thanked all those who have responded to their calls about serving on the board next year. The nominees for officer for 2013 and 2014 are: President—Linda Arronge; Vice President—Robert Mason; Secretary—Pat Peak; Treasurer—Beverly Duran.

The nominees for board member are: Shirley Coleman, Jackie Fremming, Bruce Gill, Aaron Konstam, Pat Konstam, Elizabeth Lutri, Pat Mendiola, Larry Purkey, Ronnie Retzloff, Ann Springer, Virginia Wong, and Karen Matson.

OLD BUSINESS

FOSAPL Budget for 2013—Judy Wilson presented the proposed operating budget for 2013. Bruce Gill made a motion to approve the budget as presented, and **Robert Mason** seconded. The motion passed.

Judy Wilson pointed out that in 2012 FOSAPL spent 88% of its budget on library support and 12% on the administration of FOSAPL. The amount to be given to SAPL for 2013 will be presented for a vote by the Board members at the Annual meeting.

Nancy thanked the Igo Friends group for the beautiful and delicious refreshments. **Pat Mendiola** made a motion the meeting be adjourned. **Pat Bjornson** seconded the motion, and the meeting was adjourned.

Carver Library will commemorate Martin Luther King's birthday Jan. 19, 2013, from 4 to 6 p.m. Guest Speaker will be **James Howard**, President of the SAISD Board. Mr. Howard will speak about the importance of education and how Dr. King influenced him as an educator.

The Exceptional Scholars Talented Tenth for African American Women will install their dissertations into the Library for public use. There were 20 African American Women honored in September 2012 at the Carver Community Cultural Center for achieving the status of PhD/Ed. This is the second event of this type; the first was held in 2011 when 16 African American Men were honored, and their dissertations have been cataloged into the library system. In the past, universities kept these scholarly works, but now the public can utilize these scholarly materials.

that was approved by the FOSAPL Board on September 16, 2012, and by the SAPL Board of Trustees on October 24, 2012, concerning mutual responsibilities of the Friends of the Library and of the San Antonio Public Library.

- The Board is also recommending the following revisions to the Standing Rules:
- Standing Rule 1E: change "Membership Chair" to *Membership Secretary*.
- New Standing Rule 1G: The Membership Secretary shall be responsible for keeping accurate records of member contact information, making regular reports to the directors and secretary of branch group Friends, and for acquiring an adequate supply of materials needed to facilitate member recruitment. The Membership Secretary will coordinate and share information with the Newsletter and Website committee personnel as needed to ensure communication is available to all members.
- New Standing Rule 4G: The board of directors shall authorize the Treasurer to procure and maintain sufficient and appropriate liability coverage for the protection of board members and BookCellar employees and volunteers, the cost of which shall be borne by the Friends.
- Standing Rule 5D: re-ordered the language to put the Treasurer's duties first, and reference to a substitute Treasurer after that; using the same language as before
- Standing Rule 6A: added Annually, the President will request that a Task Force of at least five (5) board members other than officers be appointed by the directors to conduct the audit of the prior year's financial records. Annually, the Treasurer will request that a Task Force be appointed by the directors to plan and propose a budget for the next fiscal year.
- Standing Rule 6C: added *Website* to the list of standing committees, and <u>deleted</u> <u>"Membership"</u>
- Standing Rule 6D, added new 6D2. The Website Committee shall consist of at least five members, to include an officer, a member of the Newsletter Committee, and three (3) other members appointed by the Board of Directors. The purpose of the Website Committee shall be to facilitate the electronic communication tasks of a Webmaster, whose compensation shall be authorized annually as part of the annual FOSAPL budget. The Website Committee shall be responsible for directing and approving both the content and style presented by the FOSAPL web presence.
- Standing Rule 6D4: currently includes "... Where possible, committee members should include one person from the board of directors (recommended <u>deletion</u> of the following phrase) <u>and not more than two persons from each library branch or support group."</u>
- Standing Rule 6D5: New description of the Arts & Letters Award Committee: The Arts & Letters Annual Award Committee shall consist of at least five (5) members, and shall be responsible for planning, publicizing, and conducting the Arts & Letters Award program. The Committee shall describe standards of achievement required of nominees, shall solicit nominations, and conduct evaluations in an equitable manner. The Chair of the Committee shall be responsible for ensuring that the established budget is maintained, and for providing the Secretary with minutes of all committee meetings.

Branch Friends' Purchase Processes Are Clarified

A t the FOSAPL Board meeting of Nov. 18, Acting Assistant Director **Ruben Flores** reviewed the processes for Friends' purchases to benefit the branches. Branch Managers—who have increased responsibility to communicate with both the SAPL fiscal staff and their own Friends' officers—received training on the process in early December. The procedures are meant to decrease the time it takes for items or services to be acquired through City vendors, after the Branch Friends group has approved the expense. The recommended process is:

1. Identify Need and Obtain Quote

a. Branch Manager identifies need and obtains approval from the Branch Coordinator. (Technology or facility-related purchases will require additional approvals and processing time.)

b. Manager obtains quote (including shipping/handling charges, if any).

2. Friends Group Approval

a. Manager presents quote to Friends Group for final approval.

b. If approved, Friends Group Treasurer requests check from the FOSAPL Treasurer.

c. FOSAPL Treasurer sends check to Fiscal Office at Central Library.

3. Purchase Initiated by SAPL

a. Manager submits Spending Request Form to Fiscal Office.

b. Upon receipt of check, Fiscal Office will initiate order.

4. Receipt of Purchase

a. Manager receives order.

b. Manager notifies Friends Group and Fiscal Office that order has been received; the bill is paid by SAPL. (Item may be added to City inventory list, if appropriate.)

For items or services (e.g. pizza for teens, guitar-lessons, puppets) that are not acquired through City vendors and would not be added to the City's inventory, the acquisition process is somewhat simpler: after approval by the Friends group, the Friends group Treasurer submits a Request for Reimbursement or a Request for Payment form to the FOSAPL Treasurer; the bill is paid by FOSAPL. The Branch Manager is responsible for notifying the SAPL Fiscal Office that an expenditure for that branch was made by the Friends.

T he after-Thanksgiving half-price sale earned \$3,581 for the seven days with a steady stream of customers who bought thousands of books.

The annual volunteer appreciation luncheon and apron award ceremony was held Nov. 12 at Azuca Cocina Latina restaurant, attended by 36 volunteers and guests. Linda Arronge handled arrangements.

Six volunteers received purple aprons personalized with their names in recognition of completing at least 50 hours of work in the BookCellar. They are Mary Chance, Cynthia (Cindy) Conley, Kelly Crispin, Daniel Pena, David Stanley, Barbara Suk, and Tom Suk. They were among nine people who started working at the store during 2012. attached patches signifying 50 hours of work to the new aprons. All 40-plus volunteers combined worked a total of 55,380 recorded hours during the first 10 months of 2012, a contribution that would be worth \$40,150 if they were paid minimum wage.


"Texas Book Festival/ San Antonio Edition" Will Be One for the Books
